

Jordan Township Meeting Minutes
August 26, 2024

Present: Suzan Falco (Supervisor), Rebekah Meads (Treasurer), Amy Smith (Clerk), Jessica Morris & Kirk Falco (Trustees)

Meeting called to order with the Pledge of Allegiance at 6:00PM.

Motion to approve the meeting minutes from July 22, 2024 made by S Falco, K Falco seconded, motion carried unanimously.

Treasurer's Report was reported by R Meads.

Paid Bills were reviewed and acknowledged

Motion to pay pending bills was made by S Falco, J Morris seconded, motion carried unanimously.

Antrim Sheriff was not in attendance

Dawn LaVanway presented Commissioner Report

Jim Rathburn reported for the Ambulance Authority: Public are welcome to attend meetings which are held the 3rd Wednesday of every month at 5pm at the Fire Station.

T Sothard reported to S Falco of further contact with the homeowner on M-32 regarding clean up of their property. The owner is to begin by removing the old red mini van and make immediate plans to begin clean up of the home.

T Sothard reported to S Falco that a plot at Brown Cemetery was marked incorrectly making the last lot unsellable.

S Falco confirmed that Cemetery ordinance signs have been installed and cemetery plot pricing has been amended.

S Falco spoke with Burt from Road Commission regarding the price overage (that exceeded budget) of Mt. Bliss Rd and Burt said he would work with the township regarding the extra expense.

S Falco attending the special meeting in Chestonia twp regarding the ORV ordinance. S Falco said that many in attendance seemed opposed due to safety, maintenance, and adequate monitoring by police. Chestonia will be voting on this ordinance at their next meeting on September 9th.

A Smith reported on the State Primary election. 30 voters early voted, a total of 232 electors voted between in person and absentee ballot.

A Smith is looking for a few more interested election inspectors/poll workers. A few electors in attendance expressed interest.

The 2023-2024 audit was performed on August 22, 2024. One of the Auditors had to reconcile 12 months of bank statements in QuickBooks as it was not performed by the former Clerk. This process had to be completed prior to the auditors completing the audit.

Homeowner on Trinity Rd. has requested the township purchase a road sign for the end of the road. S Falco spoke with the county and they will not pay for a road sign. The board discussed and they

do not wish to set the precedent of using township funds to pay for road signs. K Falco motioned to deny the purchase, R Meads seconded, motion passed unanimously.

S Falco discussed the Hazardous Mitigation Policy. The policy must be adopted by October 2024 and filed with FEMA. S Falco motioned to approve, R Meads seconded, motion passed unanimously.
